Notice Concerning Change of Organization and
Appointment of a new Important Employee of the Asset Management Company

Invesco Office J-REIT, Inc. (hereinafter referred to as the "Investment Corporation") announces that Invesco Global Real Estate Asia Pacific, Inc. (hereinafter referred to as the "Asset Management Company"), to which the Investment Corporation entrusts asset management operations, resolved to change the organization of the Asset Management Company and appoint a new important employee at a meeting of the board of directors which was held today. Details are as follows.

1. Change of organization

(1) Details of change

101 Investment Limited Partnership, SDSS Investco Limited, SDSS K Investco Limited, SSF U.S. Investco S, L.P., SSF U.S. Investco C, L.P. and SOF-11 International Investco Limited, each managed by the Starwood Capital Group, commenced a tender offer on the investment units of the Investment Corporation as of April 7, 2021. The Investment Corporation subsequently received the proposal of the intention to conduct a tender offer for all of the issued and outstanding investment units of the Investment Corporation (hereinafter referred to as the "Tender Offer") from IRE (Cayman) Limited (together with its related parties, hereinafter referred to as "Invesco Real Estate"), a subsidiary indirectly wholly owned by Invesco Ltd., the parent company of the Asset Management Company on May 20, 2021. The Asset Management Company has now determined to establish a new body within the organization (the "IRE Strategy Office"), and appoint a dedicated person in charge, for the purpose of handling operational aspects regarding the Tender Offer and other related or incidental measures for the relevant parties. The Asset Management Company believes that the establishment of the IRE Strategy Office is prudent in light of the Tender Offer and will contribute to ensuring that the operations of the Asset Management Company are organized in such a way that is designed to ensure that the services provided by the Asset Management Company to the Investment Corporation are not impacted by the Tender Offer.

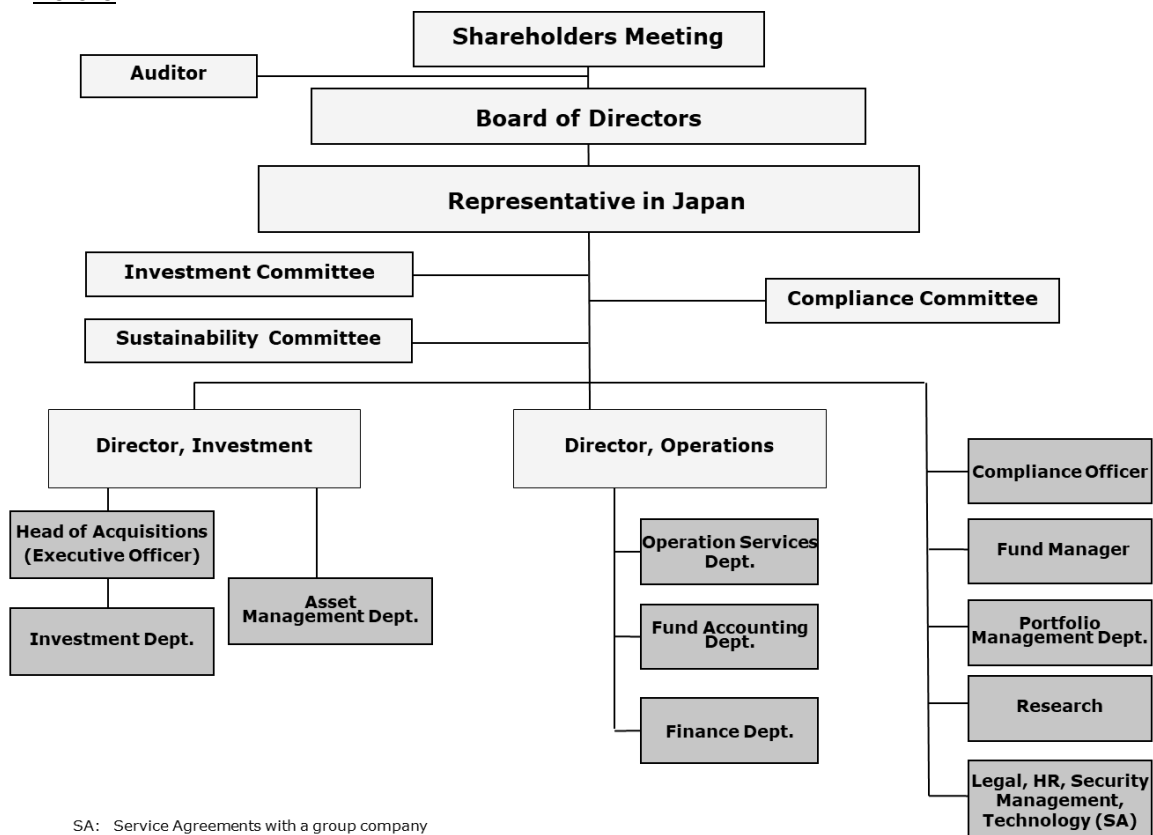

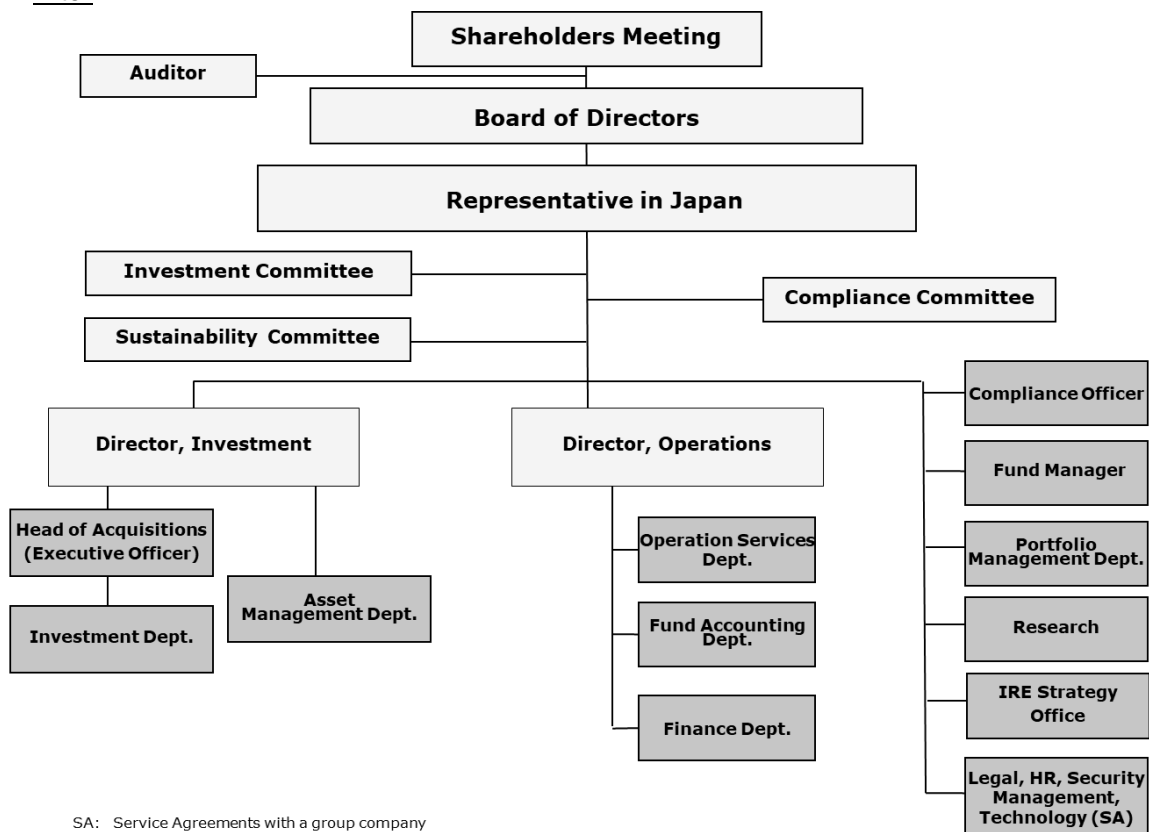
