Notice Concerning the Amendment of Conditions of Tender Offer by Starwood Capital Group

Invesco Office J-REIT, Inc. (hereinafter referred to as the "Investment Corporation") hereby announces that, with respect to the tender offer (hereinafter referred to as the "Tender Offer") by 101 LPS, SDSS Investco Limited, SDSS K Investco Limited, SSF U.S. Investco S, L.P., SSF U.S. Investco C, L.P., and SOF-11 International Investco Limited, managed by the Starwood Capital Group, (hereinafter referred to collectively or individually the "Tender Offeror") for all of the issued and outstanding investment units of the Investment Corporation, the Tender Offeror filed the "Public Notice of Amendment of Tender Offer Conditions" and "Amendment to Tender Offer Registration Statement" on June 1, 2021 and amended the Tender Offer purchase price and the minimum number of share certificates, etc. to be purchased as follows.
